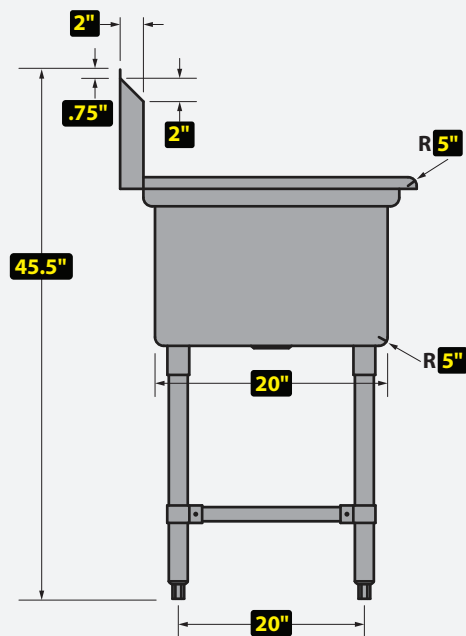
Top View

Front View

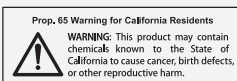
