- XV1 Model comes pre-installed with auto-clean basket.

Thermal Safety

Motor protected by internal thermal detector and overload protector.

- On/Off switch detects overloading and no voltage
- All mechanical parts are ground (earth) connected
- All equipment is 100% tested at the end of assembly.

A friction brake immediately stops the basket when opening the handle.
