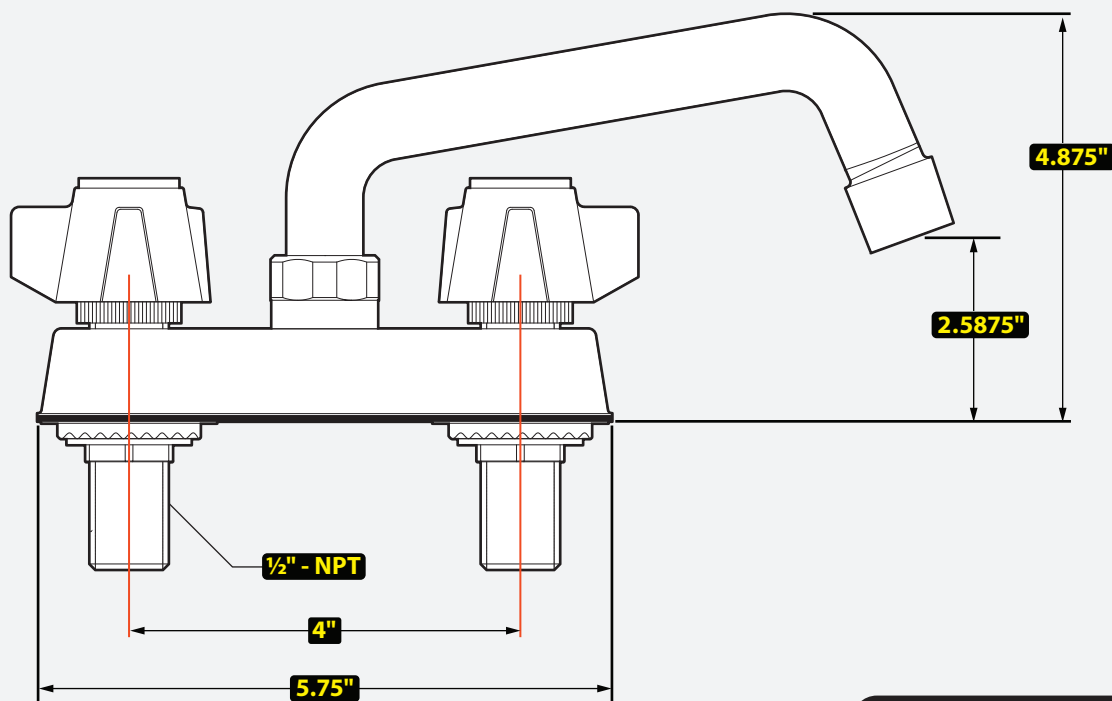

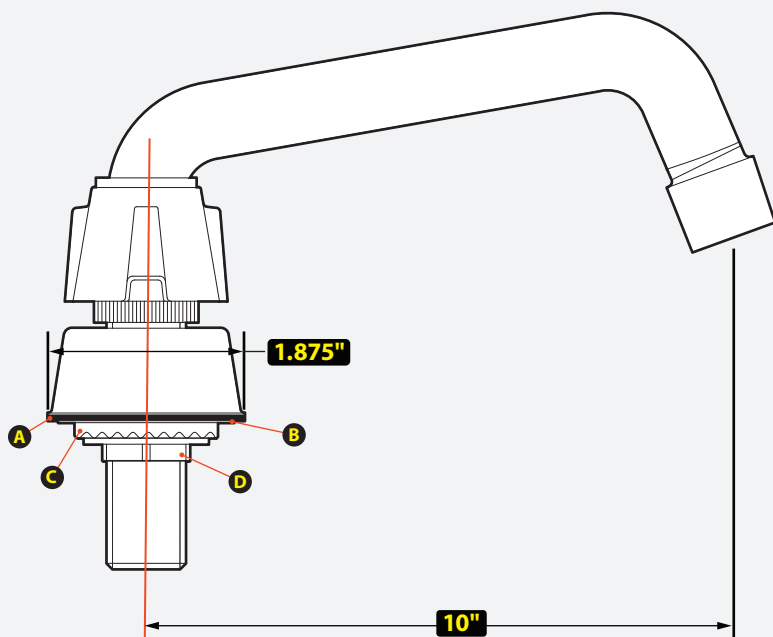

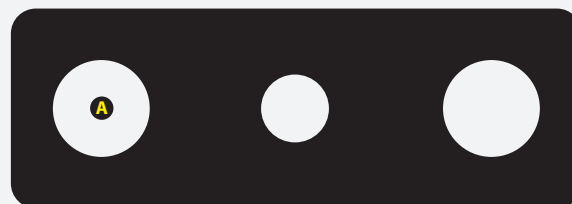

Front View



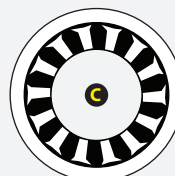
Side View



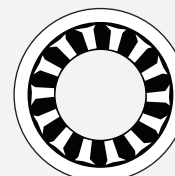

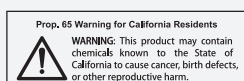
