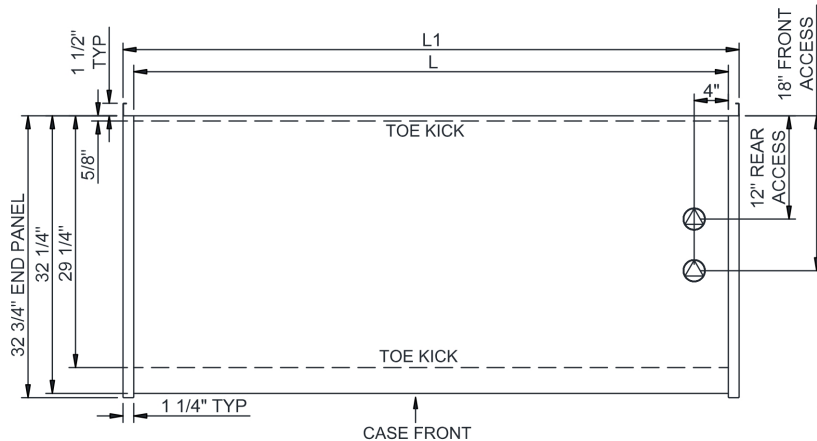

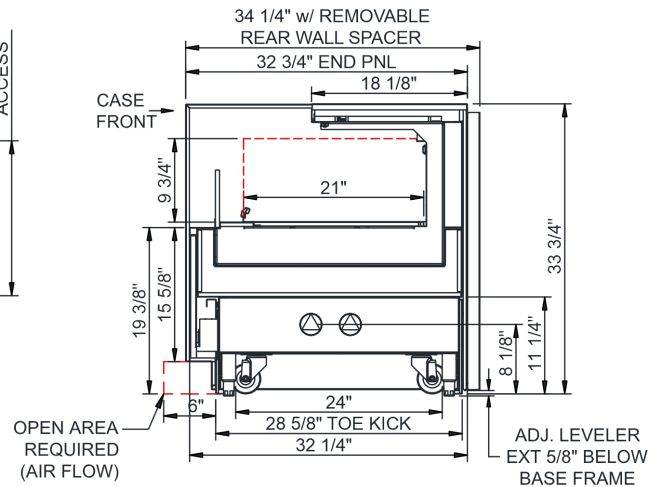

## Important Notes:

- 1) Performance issues (product temperatures, water on floor, etc.) caused by adverse conditions are not covered by warranty.
- 2) Levelers must be adjusted during installation to ensure unit is level and plumb.
- 3) Keep unit at least 15' from exterior doors, overhead HVAC vents, or any air curtain disruption.
- 4) Do not expose unit to direct sunlight or any heat source (ovens, fryers, etc.).
- 5) Front access compressor air intake at lower front, discharge from lower rear. Lower panels cannot be blocked. Wall spacers required for proper air flow. Rear access reverses air flow direction.
- 6) Front access increases case depth to 32-3/4".
- 7) If GFCI is required, a GFCI breaker MUST be used in lieu of a GFCI receptacle.
